- Copy of the Aadhar card of your ward.
- 4 passport size photographs of your ward.
- 1 postcard size photograph of your ward along with parent (*Mother, Father and the Child being admitted, no siblings in the picture*).
- Cheque/DD for the fees as per the fee structure (subject to revision).
- Cheque/DD for PTA membership fee.

All documents submitted will be subject to scrutiny and any discrepancy found may result in cancellation of the admission.




